REQUIREMENTS

- BE WILLING TO MAKE A COMMITMENT
- COMPLETE REQUIRED TRAINING
- CALL TO MAKE AN APPOINTMENT FOR A FACE-TO- FACE INTERVIEW
- FILL OUT AN APPLICATION
- COME IN FOR A FACE-TO- FACE INTERVIEW
- PASS CRIMINAL BACKGROUND CHECK
- BE 18 YEARS OF AGE OR OLDER
- HAVE RELIABLE TRANSPORTATION FOR MEDICAL ACCOMPANIMENT WHERE FORENSIC EVIDENCE IS COLLECTED
- HAVE USE OF PERSONAL PHONE.
- BE A NON-JUDGEMENTAL PERSON
